TRADE NAMES LAWS Chapter 547, Code

Section 547.1 **Use of trade name** — **verified statement required.** A person or copartnership shall not engage in or conduct a business under a trade name, or an assumed name of a character other than the true surname of each person owning or having an interest in the business, unless the person first records with the county recorder of the county in which the business is to be conducted a verified statement showing the name, post office address, and residence address of each person owning or having an interest in the business, and the address where the business is to be conducted. However, this provision does not apply to any corporation or limited liability company incorporated or organized in this state or any foreign corporation or foreign limited liability company authorized to do business in this state or doing business pursuant to an exemption in chapter 490 or 490A.

Section 547.2 **Change in statement.** A like verified statement shall be recorded of any change in ownership of the business, or persons interested in the business and the original owners are liable for all obligations until the certificate of change is recorded.

Section 547.3 **Fee for Recording**. The county recorder shall charge and receive a fee in the amount specified in Section 331.604 for each verified statement recorded under this chapter.

Section 547.4 Penalty. Any person violating the provisions of this chapter shall be guilty of a simple misdemeanor.

Section 547.5 "Offense" Defined. Each day that any person or persons violate the provisions of this Chapter shall be deemed to be a separate and distinct offense.
